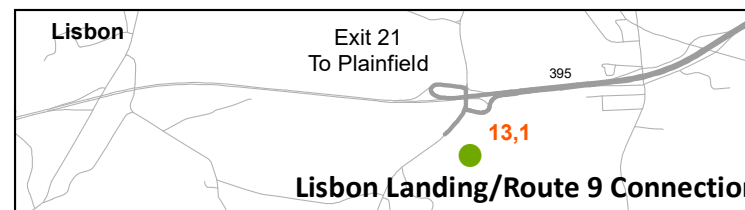
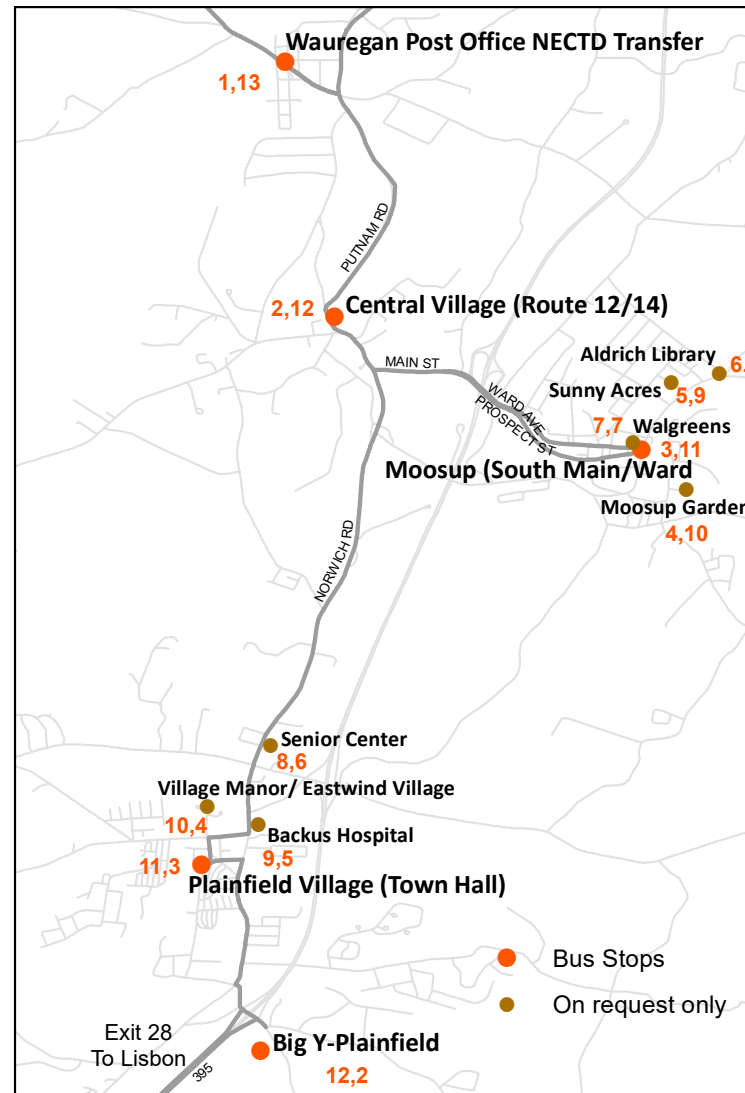

PUBLIC RIGHTS UNDER TITLE VI

The Northeastern CT Transit District provides fixed route service where persons may pick up the bus at the designated stops or you may flag the bus down at a viable/ safe location for pick-up along its route.

Additionally, the bus may be deviated up to 3/4 of a mile from the published route by contacting the District by 1:00 p.m. the day prior to the pick up date, or by Friday for weekend requests. Due to scheduling constraints -- off route service may be limited. When requested – the District will provide alternative format schedules and other transit related information. If you, or someone you know has limited English proficiency – we will help. Each of our buses is fully ADA certified and have wheel chair lifts. Additionally, our buses are equipped with bicycle racks.

The Northeastern Connecticut Transit District (NECTD) operates its programs and services without regard to race, color, and national origin in accordance with Title VI of the Civil Rights Act. Any person who believes she or he has been aggrieved by any unlawful discriminatory practice under Title VI may file a complaint with NECTD or the Federal Transit Administration (FTA).
